Benjamin A. Leonard is the Managing Partner of the firm's Atlanta office. He focuses his practice primarily on defending employers and insurers under the Georgia Workers' Compensation Act (Title 34). He is also one of a handful of Georgia practitioners who has been trained and certified in Medicare Set Aside allocation and implementation.

Mr. Leonard received B.A. degrees in Political Science (1995) and History (1996) from the University of North Carolina at Asheville, and was a four-time letterman on the Cross-Country and Indoor and Outdoor Track teams. He received his J.D. from Mercer University Walter F. George School of Law in 2000. While in law school, Mr. Leonard served on the Board of Governors and as a student editor of the *Journal of Southern Legal History*. He also served as Head coach of the Mercer University Men's and Women's Cross-Country teams.
